01. CONFIRMATION OF PROCEEDINGS OF LAST GOVERNING BODY MEETING

After the welcome address of Dr (Smt) G.T. Samantary, Principal & Secretary of the college the proceedings of the last meeting of the Governing Body held on 3rd March, 2011 were confirmed.

02. ISSUE OF RECORD OF RIGHTS OF LAND IN FAVOUR OF HIGHER EDUCATION DEPT.

As advised by the then President, the Principal has written letters to the Tahasildar, Koraput regarding the transfer of land to the Higher Education Dept, Odisha vide this office letter no- 772/ 2011, dt 23.04.2011 and for the land demarcation vide letter no 1221/2012, dt 13.07.2012. Several communications have been made from time to time regarding the matter, still the ROR is not released. Considering the urgency of the matter, vide letter no- 58/XXVI-9/17, dt 07.01.2017 the office of the Collector, Koraput directed the Tahasildar, Koraput for the early issue of the ROR. The Principal requested the President for the issue of the ROR in favour of Higher Education Department, Govt. of Odisha before the signing of the MOU with the World Bank. The President has advised to monitor the issue of the RoR with the Tahasildar Koraput.

03. APPROVAL OF UTILISATION OF RUSA GRANTS

The Principal submitted the proposal for post-facto approval of the utilization of the RUSA grants before the members of the Governing Body. Dr. K. K. Behera, Asso. Professor in Commerce and Accounts Bursar presented the bill-wise expenditure of RUSA grant amounting to 1.22 Crore towards the creation of New Girls Common Room and Sports Complex of Rs 70 lakh, Up-gradation of existing facilities of Rs 8 Lakh and purchase of Books, Computers, Water Purifiers, Desk cum Benches and TVs for Hostels of Rs 44 Lakh. The utilisation certificate to the extent of 1.22 Crore has already been submitted. The Principal declared that all the procedures as instructed by the Govt. for utilization of RUSA grant has been followed. The members of the Governing Body gave their assent for post-facto approval of the RUSA Expenditure made in 2015- 2016 and 2017- 2018.

The Governing Body post-facto approved the expenditure under RUSA Grant.

04. APPROVAL OF IDP FOR IMPLEMENTATION OF OHEPEE

The Principal informed the House about the submission and selection of the Institutional Development Plan (IDP) of the college under the OHEPEE Programme. Sri D. K.Pattnaik, Asst. Professor in Botany and IDP Coordinator presented the Plan and year-wise budget of expenditure to the tune of 1.53 Crore each year for five years.

The Governing Body approved the proposals of IDP for the implementation of OHEPEE.

05. SHORTAGE OF TEACHING AND NON-TEACHING STAFF

The Principal informed the members of the Governing Body about the acute shortage of both teaching and non-teaching staff positions of the college that creates many difficulties while running the institution. More than 50 percent posts are lying vacant both in the teaching and non-teaching sectors. Collector and President of the GB expressed his concern and assured to take appropriate steps to fill up the vacancies. He also requested the local MP and MLA to persuade the Govt. for the early filling of vacancies.

06. INCREASE IN FEE STRUCTURE

For the last more than 30 years the sessional fee structure has remained unchanged even after the substantial increase in price of all the articles. As a result of which fund shortage is posing serious problems in conducting various activities relating to students matters. Hence, the Principal requested members of the Governing body for the approval of the fee hike as proposed.
